## 4 First Aid Measures

**Inhalation:** If inhaled, remove to fresh air. Seek medical attention if breathing problems develop.

**Skin Contact:**

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if irritation or rash develops.

**Eye Contact:**

In case of eye contact, rinse with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing for at least 15 minutes. Seek medical attention.

**Ingestion:**

If swallowed, do not induce vomiting. Immediately rinse mouth with water. Give a glass of water to drink in small sips. Never give anything by mouth to an unconscious person. Seek medical attention.

Inhalation: May cause respiratory irritation.

Inform respective authorities in case of seepage into water course or sewage system.

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material.

Collect the spilled material and place into a suitable container for disposal.
